APPLICATION FOR GOLD BOND PLACE IN THE 2022 LONDON MARATHON TERMS & CONDITIONS

DEFINITIONS

The following describe the definition of words used in the following Terms & Conditions

1. **The Charity** – means the North Wales Cancer Appeal a charity operated under the umbrella of the Betsi Cadwalader University Health Board Trust Registered Charity Number 1138976
2. **Gold Bond Marathon Place** – a place in **The Marathon** that is secured and paid for by **The Charity**
3. **Official Application** – means the completion, signing and submission of an **Official Application Form** to be considered to obtain a **Gold Bond Marathon Place**
4. **The Marathon** – means the London Marathon run in the year for which this application is made – applications are made in the year prior to the year **The Marathon** is run
5. **The Applicant** – The person who submits the **Official Application** form and signs it
6. **Minimum Sponsorship** – the minimum amount of sponsorship to be raised by The Applicant as defined **by The Charity** by the **Final Sponsorship Payment Date** indicated defined as:
7. **Final Sponsorship Payment Date** – the date by which the **final Minimum Sponsorship** total must be reached and paid into the Charity account which for 2022 will be **31st January 2023**
8. **Closing Date** – the date by which the **Official Application** must be submitted as note on the **Official Application** form
9. **Gift Aid** – An additional 20% added to the total donation for eligible UK tax payers

TERMS & CONDITIONS

By signing and submitting the **Official Application Form**, **The Applicant** agrees to the following **Terms & Conditions**:

1. To use all best endeavors to adequately and properly train to complete **The Marathon**
2. To guarantee to
 - a. Raise at least **50%** of the **Minimum Sponsorship** ie. **£1,000** by the date of the Marathon – 2nd October 2022
 - b. Raise 100% of **Minimum Sponsorship** of **£2,000** by the **Final Sponsorship Payment Date** or
 - c. Make up any shortfall in Sponsorship personally to reach the **Minimum Sponsorship** target by the **Final Sponsorship Payment Date**
Note the total raised excludes any Gift Aid the Charity claims
3. To make sure all outstanding sponsorship money is either handed to a Charity Committee Member for payment into the Charity bank account by the **Final Sponsorship Payment Date**
4. To make every effort to attend any photo call/promotion event arranged by The Charity to boost fundraising targets
5. To allow The Charity to publish photographs and details of The Applicant's fundraising activities and on-line sponsorship page
6. Endeavour to get any sponsor who is eligible to sign a form for The Charity to claim **Gift Aid** against any donation.
